Dear resident,

Second Secure Bike Storage Consultation

We wrote to all residents in November 2020 and January 2021 about the proposed installation of an additional secure bike storage unit.

There has been some feedback that there may not be a need for the second secure bike storage unit and we want to confirm if this is the view of Lugard House residents. We want to work with you, so we're running this consultation to confirm what level of support there is for this improvement.



Here's a picture of the type of storage. It's designed for adult bikes (children's bikes need to be kept inside residents' homes).

There would be no charge for the installation of the bike storage and no charge to use them.

The Council will only charge for a replacement key if residents lose theirs.

We've already set funding aside for this proposed improvement and if there is enough support, we'll work with you to get this installed. If there isn't support for the proposal that's not a problem and we can reallocate the funding for this secure bike storage unit to another estate.
